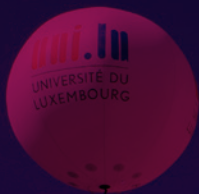

She received her degree in law from the University of Bologna and her PhD in criminal law and procedure from the University of Bologna and the Université Paris 1 Panthéon-Sorbonne. She has held research stays and fellowships at numerous universities including the University of Cambridge, Université Paris 1, and the Max Planck Institut. Additionally, she worked as an attorney at the Bologna Bar Association with a specialization in financial criminal law and white-collar crime, as a free-lance translator for the European Court of Justice, and as a lecturer both at the Université Paris 1 Panthéon-Sorbonne and at the University of Bologna. He has frequently been called upon for his expertise at national level in France, including most notably his time as an elected member of the Conseil national des universités and as a member of the jury of the second concours d'agrégation de droit privé. Prof. Ancel served as the Chair of the 2014 Reform Committee of the Faculty's Bachelor programme in law.

In Luxembourg, as a member of the European Criminal Law Academic Network, Prof. Braum has published several articles on criminal law and criminal procedures, always with an interdisciplinary orientation.
